The theme of this year's convention was "Full STEAM Ahead." "STEAM" is the newest acronym. It is STEM but with an A added for the arts—Science, Technology, Engineering, Arts, Math. With STEAM, students don't have to be scientists or engineers—they can be designers, digital artists, coders, etc. as well as scientists and engineers. That's the theory.

The speakers at this year's convention, held in Medford, were excellent! They focused on the personal safety aspects of Title IX.

*Brenda Tracy, Winner of the 2016 Breaking Barriers Achievement Award—Campus Assault: Her Story and what She is Doing About it in the OR State Legislature. (She was flying to Washington D.C. the next day to meet with Vice President Biden.)

*Marjorie Trueblood-Gamble, SOU Director of Diversity and Inclusion—Title IX Compliance at Southern Oregon University.

*Catherine Lhamon, Assistant Secretary for Civil Rights with U.S. Dept of Education— Requirements of Title IX in Regard to Sexual Harassment and Violence.

*Trish Garner, AAUW of OR Public Policy Chair—AAUW of OR Public Policy Updates.

These women were the speakers. Pioneer Park Rebuild Project Finally Wraps Up

The arson fire in October 2012 destroyed the popular playground that the Pendleton AAUW Branch helped to build years earlier. Following a lot of time, coordination, and fundraising, the Rebuild effort culminated in a very productive and successful week-long community build project in June 2013. Several hundred community volunteers labored, from a couple hours to helping every day, in reconstructing the new and improved playground. Local businesses and foundations generously donated funds towards the project budget, with several already having donated for the original build. A thank-you barbecue followed for all the volunteers and donors, and the playground reopened to much fanfare and applause.

A dedicated small group completed some more work (those damn pickets!) in September and December 2013 (donor board). This was Phase I of the Rebuild. The Committee realized that some items just could not be completed during this initial work, so a Phase II was organized. The main feature of this final round was to build a covered picnic shelter near the playground. This would provide parents and families a place for small gatherings close to the playground area, so that kids could be playing inside the fenced area while parents could be relaxing, barbecuing, and eating away while keeping an eye on the young ones.

Following some unforeseen complications involving the historic cemetery aspect of the park, the picnic shelter was finally purchased and installed. The style mimics other shelters found in parks across the City. The final electrical wiring and the completion of the sidewalk/small retaining wall along the eastside of the playground along 4th Street also took a bit more time than was anticipated. However, things finally got completed by summer 2016!

All of the remaining funds have been used or allocated (some tree plantings and maintenance issues, with the tree house are still pending) but for the Committee members (Karen King, Marty King, and Chuck Wood and David King—community volunteers extraordinaire), the project is DONE!
