AAUW PENDLETON BRANCH GENERAL MEETING MINUTES OCTOBER 1. 2015

We met at the Vert and enjoyed Halloween treats. Twelve members and five guests were present.

Bob Patterson gave a Basic City Budget presentation which was very informative. An overview of how the \$5.00 utility fee and a $.05\phi$ gasoline tax would affect the budget was given. Then City Councilmen Chuck Wood and Al Plute talked about and urged passage of the gas tax. The information was given in a clear, understandable manner and questions were answered.

The meeting was opened at 8:23 p.m. by Co-President Marlene Krout, and 11 members were in attendance.

The minutes of September were approved as received.

Dianne Barnes reported there is \$556.00 in the checking and \$7,441.00 in the savings accounts.

Membership: Jan Bruning reported there are still two members who have not paid their dues.

Marlene stated that her emphasis for her two year term will be to increase membership. She plans to go to the Chamber meetings, the Kick It Up after 5 events, and morning buzz in order to make AAUW more visible in the community. She would welcome anyone else to join her.

BUSINESS:

- 1. Grapefruit: Kathy Ward urged use of the deposit slip to be included with each order given to her. Through this she can more easily reconcile the orders and moneys received. The charge to us has increased by .25¢, so our profit on each box will be \$5.00. Renee has sent notices to many surrounding Chambers of Commerce in an attempt to sell more boxes.
- 2. STEM: Karen King presented seven STEM project options she has reviewed. Her choice would be to give the \$500.00 toward a PHS Girls' Robotics Team. There are three teams now with only four girls participating. Matthew Campbell has four more girls interested without even announcing the possibility of the new team. Since Karen has spoken to him, he is very excited and already looking for other sponsors toward the \$3,000.00 needed for the program. Individual donations could be given toward the team and they would be tax deductible. Judy Witte moved and Kathy Ward seconded the motion to earmark the available STEM funds for this project. No money will be given until all the funding has been attained. Thank you Karen for all your work on this endeavor.
- 3. BMCC Scholarship winner: Karen introduced Julie Stratton who is a first year nursing student at BMCC. She grew up on a Century Farm in Pendleton, has two children, and plans to continue to live and work in this community. She even volunteered to sell grapefruit---yah Julie.
- 4. Amy Bedford Funds: Karen King and Dianne are still working on meeting with Margaret Gianotti to see how much of the original \$500.00 is left in the fund at BMCC. This fund has been used to pay for taking the GED test for qualified students hoping to enter BMCC. There is \$1,400.00 left in the fund in our treasury. Marlene is asking for members to think of how this could be best used as a memorial to Amy.
- 5. Renee Struthers discussed One Member/One Vote. Now each branch has a certain number of convention votes based on the number of members in said branch. It is being suggested that it be changed to every member having one vote. Renee will find out more details on how this would work

and report back to us. Her term as NE District Director will expire 6/16. Anyone interested in filling that position should talk to Renee about the steps needed to be taken to apply.

- 6. Mother-Daughter choices: Mary Davis and Kate Ely are working on this and request members to come forward if they'd like to be a presenter. It will be in January and February.
- 7. Please give information for our website to Marty King.
- 8. AAUW National is encouraging more members to participate in the Action Alert system. There is only 15–20 percent participation now. Marlene shared that it is very easy to do.

Julie Stratton, Our BMCC Scholarship Recipient

Julie Stratton of Pendleton received a \$1,000 scholarship from the Pendleton branch of the American Association of University Women. Stratton grew up on a Pendleton area family farm along with three older brothers. Her parents, Dave and Sandy Umbarger, are a third-generation farming family.

Starting her education at McKay Creek Elementary, she graduated from Pendleton High School in 1993. Continuing her education, she graduated in May 1997 from BMCC with an associate degree in accounting. Stratton was married in June 1997, and the new couple started their own business in July 1997. It was busy few months.

Working at a bank for several years, Stratton then became an ophthalmologist assistant. In this position, she fell in love with the medical field and helping patients. Stratton determined she would eventually return to school and become a registered nurse.

She became a stay-at-home mom when her daughter was born in 2006, followed by her son in 2010. After a divorce in 2013, Stratton decided to go back to school and fulfill her ambition and dream of becoming a nurse.

PHS Girls Robotics Team

At the October 1, 2015, meeting, AAUW Pendleton Branch voted to support a PHS Girls' Robotics team as our STEM (Science, Technology, Engineering, Math) project for 2015–16. I had contacted several organizations in search of a STEM project, and this project stood out as something that will benefit a number of local girls, not only for this year but also in the future.

The robotics teacher/coach is Matthew Campbell, who is extremely enthusiastic about his robotics' students and the potential for a girls' team. Prior to Matthew's and my first conversation, there were 4 robotics teams, each with 8–14 students. There were only 4 girls on these veteran teams. After our first conversation, via emails, Matthew got excited about forming a girls' team and began writing grants. He currently has \$1,200 in grants committed in addition to Pendleton branch's \$500.

The cost of starting a new team is approximately \$3,000, which includes national registration (\$275), tech hardware (\$450; reusable), a base robotics kit (\$577; reusable), spare parts and tools (\$600; some consumed, some reused), a team laptop (\$850), and spirit gear, such as T-shirts (\$250). Matthew pointed out that the initial cost is the easy part because there are additional costs, such as some parts that are consumed and costs to travel to competitions.

It has been less than a month since Matthew and I first discussed the possibility, and with his characteristic enthusiasm, Matthew has already started the girls' robotics team, with 9 girls currently on the team. He has been using spare parts to get them started but requested our grant money to buy supplies while he waits for the other grants. The check from our branch has been delivered to PHS, so Matthew was able to order the main competition kit.

It would be great if our branch members could add their support to this project and match or exceed the \$500 branch donation. (much like we did with the EO Strings project) Donations can be made to PHS Robotics, which is a 501(c)(3), so donations are tax deductible. If you wish to donate, you can mail/deliver checks to PHS or the school district office OR give them to me, and I will take them to the office and request a donation slip for each. If you mail/deliver yourself, please put AAUW on the "FOR" line and let me know the amount as I would like to keep track of our branch donations for the record.

I am very excited about this project and look forward to receiving more updates from Matthew so I can keep our branch updated on the progress.
