# Grapefruit Sales Will Begin Soon

## **Grapefruit Plan for COVID-19 Times**

The AAUW Board decided to go ahead with the grapefruit sale this year. This is the plan to keep our members and customers safe during the coronavirus pandemic.

- All grapefruit must be paid for in advance! We will order only boxes that have been paid for. Cash or checks made out to AAUW are accepted.
- There will be no sorting of grapefruit this year. Upon pickup of boxes, we will give customers a hand-out explaining who to call if they have bad fruit, and we will replace it. They will have ONE week to call for replacement fruit.
- All orders and money must be in to Kathy Ward by November 21. NO EXCEPTIONS! There is no Altrusa Bazaar this year, so you will need to collect money and send money and orders directly to Kathy.
- No extra boxes of fruit will be ordered this year. Inform your customers that they need to order all that they want before November 21.
- On delivery day, customers will stay in their cars! Cars will drive up in lines and one AAUW member will go ask their name and order info. You will bring that info back and check off on the master list. Then, boxes will be taken out and loaded into the customer's car.
- We will not be taking money on delivery day! Remind your customers that if they don't pay in advance, they will not get grapefruit.
- Masks will be required of all members who are working, and we will need members to help in order for this to go smoothly.
- If you are paying for a customer or are picking up for them, please make sure that you contact them and let them know. This has been a source of confusion in past years.

The Board is encouraging all members to continue to sell grapefruit. We think our plan will keep everyone safe. However, if you are hesitant to sell, please contact Kathy Ward or Karen King as soon as possible so we can give your list to someone else. Feel free to add customers but remember: **ALL ORDERS MUST BE PAID FOR IN ADVANCE!!**

### **AAUW Program Names and Fund Numbers**

**9110—The AAUW Greatest Needs Fund,** formerly called the AAUW Fund, gives AAUW the mobility to rapidly respond to new and emerging challenges or opportunities facing women and girls.

**4449**—**Economic Security Fund** ensures livelihoods for women through achieving pay equity for women, providing training in salary negotiations, and deepening women's retirement security and quality of life (includes but not limited to Pay Equity).

**4450**—**Education and Training Fund** addresses the barriers and implicit biases that hinder advancement of women (includes but not limited to STEM and Title IX)

**4451—Governance and Sustainability Fund** ensures the strength, relevance and viability of AAUW into the future.

**4452—Leadership Fund** supports the effort to close the gender gap in leadership opportunities by increasing the number of girls and women in leadership roles (includes but not limited to NCCWSL, Elect Her, \$\frac{1}{2}\text{tart}\$ mart).

**3999—The Legal Advocacy Fund** supports the protection of the legal rights of those who are facing sex discrimination, including:

**3072**— **Travel and Education Grant** informs AAUW members through educational programs delivered by LF plaintiffs and lawyers.

- **3500**—Campus Outreach Projects protects college students from discrimination, harassment, and assault through on-campus programs
- 9310—Case Support protects LAF plaintiffs by supporting workplace sex discrimination cases.
