#### GENERAL MEMBERSHIP MEETING MINUTES

October 1, 2020

The General Membership meeting was held via Zoom because of Covid-19 restrictions. Members logged on at 6:45 with the guest speaker being introduced at 7:00 pm. Seventeen members were present plus the guest speaker.

**For the Program**, Barbara Lund-Jones introduced George Murdock, Umatilla County Commissioner. Commissioner Murdock spoke on "Governing in Uncertain Times." He shared concerns with governing in the current day and added some personal experiences. e presented a very interesting and informative program followed by a question and answer session. First Zoom branch meeting was a success.

Call to Order: Co-president Kate Mace called the general business meeting to order at 7:45 p.m.

**Grapefruit:** Kathy Ward brought us up to date with our fundraiser. We are being charged \$3 more a box, so we will be increasing the cost of the grapefruit to \$23 a box or \$12 a half box. She emailed the list of customers to each member this past week. Receipts will be coming soon. All orders and money must be in by November 20. The order will not be made until that date. No extra boxes of grapefruit will be ordered this year. Deliver/Pick Up will probably be the first Saturday of December. Signup sheet will be available in November.

**Finance**: Karen King reported that the checking account had a balance of \$317.16 and \$8,160.14 in the savings account.

Karen also presented the Proposed Budget for 2020–21. After explaining the anticipated income was reduced because of expected decrease in grapefruit sales and reduction in Membership. We were able to reduce our expenses mainly because of funding for the scholarship. BMCC reported that we had \$666 balance in the scholarship account (someone hadn't used all their money) and \$190 in Amy Bedford GED account (which isn't being used). All balances were rolled into the scholarship account and only an addition \$350 would have to be added this year to meet the \$1,200 scholarship amount.

Kate Ely moved to adopt the budget as presented. Velda Arnaud seconded. Passed unanimously

**Wildhorse Gift Certificate**: Jill Heffner will be in charge of an online auction for the \$100 gift certificate to Plateau. The proceeds of the auction will go to the AAUW Funds (the original designation for the certificate.)

The meeting was adjourned at 8:09 p.m.

# Grapefruit Sales Are On

## **Grapefruit Plan for COVID-19 Times**

The AAUW Board decided to go ahead with the grapefruit sale this year. This is the plan to keep our members and customers safe during the coronavirus pandemic.

- All grapefruit must be paid for in advance! We will order only boxes that have been paid for. Cash or checks made out to AAUW are accepted.
- There will be no sorting of grapefruit this year. Upon pickup of boxes, we will give customers a hand-out explaining who to call if they have bad fruit, and we will replace it. They will have ONE week to call for replacement fruit.
- All orders and money must be in to Kathy Ward by November 20. NO EXCEPTIONS! There is no Altrusa Bazaar this year, so you will need to collect money and send money and orders directly to Kathy.
- No extra boxes of fruit will be ordered this year. Inform your customers that they need to order all that they want before November 21.
- Delivery day is tentatively December 5, 9:00 to 2:00 (note new starting time)
- On delivery day, customers will stay in their cars! Cars will drive up in lines and one AAUW member will go ask their name and order info. You will bring that info back and check off on the master list. Then, boxes will be taken out and loaded into the customer's car.
- We will not be taking money on delivery day! Remind your customers that if they don't pay in advance, they will not get grapefruit.
- Masks will be required of all members who are working, and we will need members to help in order for this to go smoothly.
- If you are paying for a customer or are picking up for them, please make sure that you contact them and let them know. This has been a source of confusion in past years.

The Board is encouraging all members to continue to sell grapefruit. We think our plan will keep everyone safe. However, if you are hesitant to sell, please contact Kathy Ward or Karen King as soon as possible so we can give your list to someone else. Feel free to add customers but remember: **ALL ORDERS MUST BE PAID FOR IN ADVANCE!!**
