Title IX's impact on equity in education

Title IX of the Education Amendments of the Civil Rights Act of 1964 was signed into law on June 23, 1972, by President Richard M. Nixon. Title IX states: "No person in the United States shall, on the basis of sex, be excluded from the participation in, be denied the benefits of, or be subjected to discrimination under any education program or activity receiving Federal financial assistance." As we reach the 50th anniversary of this landmark legislation, it is important to review its impact on educational equity.

Title IX is best known for its impact on female athletics. It requires the equal treatment of female and male student-athletes in everything from equipment and supplies to scheduling of games and practice times to recruitment to coaching. Thus it has created a more equal playing field for male and female athletes, and the number of female athletes has climbed more than ten times since the law was passed. Furthermore, Title IX has allowed women to gain the recognition and remuneration in sports they have long deserved.

Not only has Title IX had significant impact on athletics, but it has also had far-reaching effects in other areas. Title IX protects students as well as staff in elementary schools, secondary schools, colleges and universities, for-profit schools, career and technical education programs, libraries and museums receiving federal funding. The law affects all areas of education, including in the areas of career and technical education; science, technology, engineering and math (STEM); sexual harassment and assault; harassment based on gender identity; recruitment, admissions and housing; pregnant, parenting and/or married students; comparable facilities and access to course offerings; financial assistance; and student health services and insurance benefits.

Despite the progress toward gender equity realized by the passing of Title IX, there is still room for improvement. Sexual harassment continues to be a significant problem for female students, creating barriers to an equal education. In some schools, girls still do not have equal opportunity to play sports that boys have. In schools where students are predominantly racial and ethnic minorities, progress for girls in sports and academics still lags far behind that of boys. Boys and men still dominate STEM and other fields that lead to the highest paying jobs. Full implementation of Title IX will require stronger enforcement as well as more resources, training and technical assistance for schools.

All girls have the equal right to an education and associated activities free from sex-based discrimination and harassment. Each institution or organization that receives federal funding must designate at least one employee as the Title IX coordinator.

If you have questions or concerns about Title IX implementation in your school or college, contact the school or school district and ask to speak with the Title IX coordinator.

AAUW FUNDS—ANOTHER YEAR

Welcome back to another year with AAUW Pendleton. And to another year of me talking about AAUW Funds.

Most of you know what I am about to tell you, but we have new members who may not know what AAUW Funds is all about.

AAUW Funds is a term used by AAUW National to encompass several individual funds. There are four major funds. **Greatest Needs Fund (9110)** allows AAUW the flexibility to utilize contributions where they are needed most at that time; these donations are used to support new programs and are not used for administration costs. Formerly the Education Foundation, the **Education and Training Fund (4450)** champions equal access to education and works to ensure that education at every level is free from sex discrimination. Formerly Legal Advocacy Fund, the **Economic Security Fund (4449)** works to see that women achieve pay equity and also provides training in salary negotiations which in turn deepens retirement security. **Leadership Fund (4452)** supports the effort to close the gender gap in leadership opportunities.

Within each of the latter three funds there are more specific funds. (See on a following page in this newsletter.) The Economic Security Fund (formerly the Legal Advocacy Fund is now completely funded and does not need any more contributions. The Greatest Needs Fund assures that struggling funds will have support as needed.

Throughout the year contributions may be made to any of these funds. A minimum donation of \$25.00 allows you to honor someone, either as a "memorial" for someone who has passed or as a "tribute" to someone living. An acknowledgement is sent to whomever you designate, such as family member (memorial) or the person herself (tribute). Contributions to AAUW Funds are fully tax-deductible and can be sent to your branch's current AAUW Fund chair or made on-line at www.aauw.org/contribute. When sending a check and the designated form (found on a following page in this newsletter) to your AAUW Funds branch chair, include the fund number in the memo line and a note indicating your honoree. Currently, Pendleton's AAUW Funds chair is Jill Heffner, 3303 SW LaDow Avenue, Pendleton.

One reason for this gentle reminder is that I have received questions about donating to AAUW Funds in memory of our recent past co-president, Kathryn Chaney. I hope this answers your questions and thank you for thinking of such a special way to honor Kathy.

AAUW Program Names and Fund Numbers

9110—The AAUW Greatest Needs Fund, formerly called the AAUW Fund, gives AAUW the mobility to rapidly respond to new and emerging challenges or opportunities facing women and girls.

4449—**Economic Security Fund** ensures livelihoods for women through achieving pay equity for women, providing training in salary negotiations, and deepening women's retirement security and quality of life (includes but not limited to Pay Equity).

4450—**Education and Training Fund** addresses the barriers and implicit biases that hinder advancement of women (includes but not limited to STEM and Title IX)

4451—Governance and Sustainability Fund ensures the strength, relevance and viability of AAUW into the future.

4452—Leadership Fund supports the effort to close the gender gap in leadership opportunities by increasing the number of girls and women in leadership roles (includes but not limited to NCCWSL, Elect Her, \$tart \$mart).

3999—The Legal Advocacy Fund supports the protection of the legal rights of those who are facing sex discrimination, including:

3072— **Travel and Education Grant** informs AAUW members through educational programs delivered by LF plaintiffs and lawyers.

- **3500**—Campus Outreach Projects protects college students from discrimination, harassment, and assault through on-campus programs
- **9310**—Case Support protects LAF plaintiffs by supporting workplace sex discrimination cases.
