AAUW FUNDS

As we approach the end of 2023, and the end of the fiscal year for AAUW Funds, it's time to think about contributions—branch and individual— to the Funds. Although contributions may be made any time throughout the year, and several of us do so (THANK YOU!), the Branch traditionally makes its contribution after the Grapefruit Sale and **before mid-December** (December 31 is the end of AAUW Funds fiscal year). The Branch contribution used to be divided between the Education Fund (now the Education and Training Fund #4450) and Legal Advocacy Fund (now the fully-endowed Economic Security Fund #4449). **AAUW Funds now encourages all contributions go to Greatest Needs Fund #9110.**

AAUW Funds is a term used by AAUW National to encompass several individual funds. There are four major funds. **Greatest Needs Fund (9110)** allows AAUW the flexibility to utilize contributions where they are needed most; these donations are used to support new programs and *are not used for administration costs*. Formerly the Education Foundation, the **Education and Training Fund (4450)** champions equal access to education and works to ensure that education at every level is free from sex discrimination. Formerly Legal Advocacy Fund, the fully endowed **Economic Security Fund (4449)** works to see that women achieve pay equity and also provides training in salary negotiations which in turn deepens retirement security. **Leadership Fund (4452)** supports the effort to close the gender gap in leadership opportunities.

Within the latter three funds there are more specific funds which are listed on the following page. The **Greatest Needs Fund** assures that struggling funds will have support as needed.

Throughout the year contributions may be made to any of these funds. A minimum donation of \$25.00 allows you to honor someone either "in memorial" or as a "tribute." An acknowledgement is sent to whomever you designate, such as family member (memorial) or the person herself (tribute). Be sure to include addresses for acknowledgements of gifts.

Contributions to AAUW Funds are fully tax-deductible and can be sent to your branch's current AAUW Fund chair or made on-line at www.aauw.org/contribute. When sending a check and the designated form (on the following page) to your AAUW Funds branch chair, include the fund number in the memo line and a note indicating your honoree. Currently, Pendleton's AAUW Funds chair is Jill Heffner, 3303 SW LaDow Avenue, Pendleton.



AAUW Program Names and Fund Numbers

- **9110—The AAUW Greatest Needs Fund,** formerly called the AAUW Fund, gives AAUW the mobility to rapidly respond to new and emerging challenges or opportunities facing women and girls. This fund is where donation is needed most.
- **4449**—**Economic Security Fund** ensures livelihoods for women through achieving pay equity for women, providing training in salary negotiations, and deepening women's retirement security and quality of life (includes but not limited to Pay Equity).
- **4450**—**Education and Training Fund** addresses the barriers and implicit biases that hinder advancement of women (includes but not limited to STEM and Title IX)
- **4451—Governance and Sustainability Fund** ensures the strength, relevance, and viability of AAUW into the future.
- **4452—Leadership Fund** supports the effort to close the gender gap in leadership opportunities by increasing the number of girls and women in leadership roles (includes but not limited to NCCWSL, Elect Her, \$tart \$mart).
- **3072 Travel and Education Grant** informs AAUW members through educational programs delivered by LF plaintiffs and lawyers.
- **3500—Campus Outreach Projects** protects college students from discrimination, harassment, and assault through on-campus programs
- **9310—Case Support protects** LAF plaintiffs by supporting workplace sex discrimination cases.
