Program: Civil Discourse Speaker: Nick Nash

In these divided political times, building consensus and broad support is crucial for our system to function effectively. Engaging in conversations across divides helps us find common ground and build a stronger democracy. But how do we have constructive conversations with people we disagree with? Civil discourse is constructive communication characterized by mutual respect, openness, and attentive listening.

Dr. Nick Nash will lead us in a conversation exploring civic engagement and the importance of civil discourse. Nick Nash is a Philosophy and Writing instructor at Blue Mountain Community College. He also owns a small consulting company called Eastern Oregon Business Source that helps local organizations with fundraising and professional development.

Outside of work, Nick is a board member for the Umatilla County Special Library District and a Conversation Leader for the Oregon Humanities Conversation Project. He received his BA from Portland State University (2011), his MA from The University of Wisconsin-Milwaukee (2013), and his PhD from the University of Western Ontario (2017)—all in Philosophy. Nick is grateful for the opportunity to live in, and give back to, the place where he was born and raised.

WHO: Peacemaker Dr. June L. Lorenzo — An attorney, consultant, and human rights advocate, Dr. Lorenzo is Laguna Pueblo and Diné (Navajo Nation). Holding a JD and PhD, she currently practices law in New Mexico and advocates for the rights of indigenous peoples before the United Nations and Organization of American States bodies.

WHAT: A community gathering to discuss cooperative peacemaking efforts with indigenous peoples in the United States and the world.

WHERE: First Presbyterian Church, 201 SW Dorion Ave., Pendleton, OR.

WHEN: Sunday, September 29, at 4:30 p.m. Light snacks will be provided.

WHY: Building peace with neighbors requires a deep understanding of thehistorical and current contexts surrounding relationships with indigenous peoples. Dr. Lorenzo is uniquely qualified to lead a conversation about these relationships and explain current, complicated issues. Together, we will learn and exchange ideas.

Oh my. Here it is—October already. And while Karen is priming us for our annual Grapefruit Fundraiser, it is also time for me to talk to you about an AAUW national program. Most of you know what I am about to tell you, but there are new members who may not know what AAUW Funds is all about.

AAUW Funds is a term used by AAUW National to encompass several individual funds. There are four major funds. **Greatest Needs Fund (9110)** allows AAUW the flexibility to utilize contributions where they are needed most at that time; these donations are used to support new programs and are not used for administration costs. Formerly the Education Foundation, the **Education and Training Fund (4450)** champions equal access to education and works to ensure that education at every level is free from sex discrimination. Formerly Legal Advocacy Fund, the **Economic Security Fund (4449)** works to see that women achieve pay equity and also provides training in salary negotiations which in turn deepens retirement security. **Leadership Fund (4452)** supports the effort to close the gender gap in leadership opportunities.

Thank you to the Pendleton Branch for your continued annual financial support of AAUW Funds.

Besides being supported by The Branch, AAUW Funds is also generously supported by individual members. Thank you, those of you, who have made contributions throughout the year. AAUW Funds fiscal year is January 1-December 31. If you are planning to contribute, remember the deadline for getting your checks to me is December 15. You may also make your contributions online.

Throughout the year contributions may be made to any of the above-listed funds. A minimum donation of \$25.00 allows you to honor someone either "in memorial" or as a "tribute". An acknowledgement is sent to whomever you designate, such as family member (memorial) or the person herself (tribute). Contributions to AAUW Funds are fully tax-deductible and can be sent to your branch's current AAUW Fund chair or made on-line at www.aauw.org/contribute.

AAUW Program Names and Fund Numbers

- **9110—The AAUW Greatest Needs Fund,** formerly called the AAUW Fund, gives AAUW the mobility to rapidly respond to new and emerging challenges or opportunities facing women and girls. This fund is where donation is needed most.
- **4449**—**Economic Security Fund** ensures livelihoods for women through achieving pay equity for women, providing training in salary negotiations, and deepening women's retirement security and quality of life (includes but not limited to Pay Equity).
- **4450**—**Education and Training Fund** addresses the barriers and implicit biases that hinder advancement of women (includes but not limited to STEM and Title IX)
- **4451—Governance and Sustainability Fund** ensures the strength, relevance, and viability of AAUW into the future.
- **4452—Leadership Fund** supports the effort to close the gender gap in leadership opportunities by increasing the number of girls and women in leadership roles (includes but not limited to NCCWSL, Elect Her, \$tart \$mart).
